## **Aspen Cove HOA Association Meeting Notice**

June 24, 2017

This email is to notify all members of the Aspen Cove at Scofield Home Owners Association of the upcoming meeting on June 24, 2017. It will be held at the common area pavilion at 1:15 pm. Each board member will make a brief report to the members concerning their specific responsibilties. At the January association meeting, we discussed the tremendous cost for snow removal this past winter. We have exceeded the 2017 snow removal budget by \$3442, and we still need to have funds available for the pending winter months. We are proposing a special assessment to replace the current budget shortfall and provide sufficient funds for the forthcoming winter months.

Our current annual dues are no longer sufficient to keep the association operating within the modest budget. In fact, our 2017 budget was approved, at our January meeting, with a deficit of \$6,950. Some funds, that have been generated over the past few years, can be used to make up this shortfall. However, we cannot continue to operate this way year after year. The last increase in our dues was over 10 years ago. Inflation has impacted our ability to keep up. We have a proposal to present at the meeting that we feel will resolve this problem over the next few years. Those present at the January meeting felt that a modest increase in our dues would be advisable.

For those of you who know that you will not able to attend, attached is a proxy ballot that you can complete and appoint someone who will be at the meeting to vote your wishes, concerning the two budget proposals. Your executed proxy ballet must be available at the meeting before the voting takes place to be considered. If you have any questions please feel free to contact a member of the board.

Please mark this date on your calendar and plan to attend. Your voice is welcome and will be appreciated. This meeting will follow the work project scheduled for the same day at 10:00 am and the picnic that begins about 12:30 pm. The activities will be held at the pavilion. If we have poor weather, we will post the location of the picnic and the meeting to follow at the pavilion.

Aspen Cove is a beautiful place that we all enjoy. Please come a get involved in these activities and especially the operation of the association.
